

UPPER MANAGEMENT CO.

— UNIVERSAL TYPE LICENSE —

This is an End User License Agreement (“EULA” or “License”) between you, (“The User” or “Licensee”), and Upper Management Co. (“Licensor” or “UMCO”). Upper Management Co., its partner companies, and successors are the sole owners of the intellectual property rights and copyrights to any of the designs held in the Font Software, (“Fonts”) represented by this EULA.

This EULA is a legal agreement and becomes a binding contract upon the download and/or installation, copying, or use of the Font Software. This Agreement governs the terms of use and misuse of the design of the Fonts embodied in the software along with any current or future additional pieces added to the Font Software. By downloading and/or installing, copying, or using the Font Software, you agree to the terms of this Agreement listed below and are held liable under the jurisdiction of the state of Texas and the United States of America. If you do not agree to the terms, do not purchase this License, or download, or install, or copy, or use the Font Software.

Upon the downloading and installation of the Font Software, you acknowledge that you have fully read and understand the clauses contained within this EULA. It is the duty of the Licensee to ensure all license restrictions are correctly observed and communicated with all future Users of the Fonts.

I. GRANT OF LICENSE

Upon payment in full, Upper Management Co. grants you non-exclusive and terminable license to use the Font Software and the designs created by the Font Software. Your license use must be in accordance with the terms and conditions of this Agreement listed below in order to be considered valid. Upon payment in full of the appropriate license type, you become a User of the Font Software, not an owner of the Font Software. No intellectual property rights or copyrights are transferred to The User upon entering into this EULA with UMCO.

You are not allowed to use the Font Software with more than five (5) concurrent Users. If at any time, your use of the Font Software exceeds the number permitted in Your License, you agree to immediately notify Upper Management Co. and purchase the proper license. These five (5) Users do not have to be at the same physical location; they must only be part of the same company or working on the same project for a Client.

If you are an agency, studio, or consultancy working on a client project, the End User (“Client”) must also purchase a license according to their use case.

2. THE LICENSE

This license represents a universal license for Desktop and Web. Upon payment in full, The Licensee will receive a download link from the internet of all file formats associated with the Font Software. These formats include OTF for desktop, WOFF and WOFF 2 for web. Depending on the design requirements of The Font Software and your License, a TTF format may also be provided for Variable font access.

3. AUTHORIZED USES

The Font Software may be used for most purposes including but not limited to logos, logotypes, advertisement, titling, documents, websites, social media (for accounts under 100,000 followers), books, and ebooks. These uses do not extend to the use cases listed below as Misuse of the Font Software. Please contact UMCO with any questions around Authorized Uses of the Font.

4. MISUSE OF THE FONT SOFTWARE

This License does not cover certain usages of the Font Software. Extended usages outside of this Agreement may be purchased via a more permissive License from Upper Management Co. Certain uses are strictly prohibited outright and cannot be covered by any Font Software from UMCO. What usages outside the normal License are possible is up to the sole discretion of Upper Management Co.

This License expressly prohibits the embedding, inclusion, calling or linking of the Fonts within hardware and software in any form whatsoever. This includes, but is not limited to, video games, server-side applications, online document creation, mobile apps, kiosks, and OEM products or software. If You wish to use the Fonts for such purposes, contact Upper Management to discuss an expanded License.

This License expressly prohibits use of the Font Software or any edited, rasterized, or rendered version of the Font within film, television, or streaming video content. This includes, but is not limited to, opening titles, identities, marks, branding, logos, or logotypes. If You wish to use the Fonts for such purposes, contact Upper Management to discuss an expanded License.

This license expressly prohibits use of the Font Software or any edited, rasterized, or rendered version of the Font that aides in the creation of alphabet products such as, but not limited to: house numbers, stamp sets, rub-on letters, adhesive alphabet letters, Metal Type, alphabet punch and die sets or other methods for use in making such products. If You wish to use the Fonts for such purposes, contact Upper Management to purchase the correct License for the Font Software

Unauthorized uses of the Font Software include: any type of work or use within Artificial Intelligence, Generative Artificial Intelligence, Machine Learning Based Applications, NFTs, Cryptocurrencies, Guns or Ammunition, Tobacco, Vape Products, Pharmaceuticals, Supplements, Political Campaigns, Oil & Gas, or Automotives. You are not entitled to use the Fonts for any form of video content within these Unauthorized

Uses for paid advertising (e.g., a commercial), whether on social media platforms, online channels, TV networks, streaming services or otherwise. You agree to indemnify Upper Management Co. for any third-party claim that arises as a result of any unauthorized use by You of the Fonts.

Further unauthorized uses of the Font Software include as training data or source material, anonymous or not, in any Large Language Models, Generative Ai, or any type of machine learning based application. Current models of this are seen as theft and any use of this within an Ai application will be seen as outright theft of the Intellectual Property and Copyright held within this Font Software and will prosecuted to full extent of the law.

5. NO EDITS

Fonts may be outlined (such as in Adobe Illustrator) and edited as the User sees fit for uses in logos, logotypes, advertising, etc. This is encouraged as a primary use case of the font software.

The Font Software may not be edited, redrawn in part or fully, derivative work created from, reverse engineered, renamed, resold, or shared outside of a single project without the express and prior written consent of Upper Management Co. Single characters of the Font Software or the general design and intellectual property within the Font Software may not be altered, edited, or changed in any way without the express and prior written consent of Upper Management Co. UM is the only party able to edit the Font Software and any editing by a third party without prior written consent by Upper Management Co. is considered a breach of this agreement and liable for any and all damages, lost revenue, time, and legal fees, plus further unexpected fees from the breach of contract. Changing the file format beyond what formats you have been given as your particular License is also considered a breach of contract. Please contact Upper Management directly for any questions about this policy.

6. EXPANDED LICENSE TIERS

Expanded use cases and larger License tiers are available. Please contact Upper Management for details on expanded Licenses.

7. THIRD PARTY USERS

Any third party ("Users not directly employed by the Licensee" or "Contractors") Users may use the Font under the terms of the license and are not counted toward your concurrent user number. This includes printers / agencies / freelancers ("Subcontractor"). However, upon completion of their work involving the Licensee and/or after termination of the relationship with the Licensee, their copies must be destroyed. Failure to destroy copies of the Font Software by any Subcontractor will result in a breach of contract and require the Licensee to reimburse Upper Management for the cost of the Subcontractors License plus any damages.

Licenses are non-transferable and a new license must be purchased if required for independent continued usage.

8. ARCHIVAL COPIES

Archival copies of the Font Software may be kept. However, these copies must not be used by users outside of the number of concurrent users outlined in your License. Should this agreement be breached, all archival copies must be destroyed and uninstalled from systems until a new agreement is obtained.

9. NONLIABILITY

You expressly acknowledge and agree that use of the Font Software is at your sole risk. The Font Software and related documentation are provided "AS IS" and, except as noted herein, is without warranty of any kind and Upper Management and its affiliated companies hereby expressly disclaims all warranties, expressed and implied, including, but not limited to, the implied warranties of merchantability and fitness for a particular purpose. Upper management, its owners, or affiliates does not represent or warrant that the operation of the font software will be uninterrupted or error-free, or that the font software is without defects. the font software is not fault-tolerant and is not intended and was not designed or manufactured for use in any circumstances where fail-safe operation may be required. The font software may not be used in manufacturing, navigation, and process control equipment or in any other circumstances where the use or failure of the font software could lead to death, personal injury, property damage, or severe physical or environmental damage. Under no circumstances shall Upper Management, any of its members, employees, owners, affiliates, or successors be liable to you or any other party, whether in contract or tort (including negligence) or otherwise, for any special, consequential, or incidental damages, including lost profits, savings or business interruption as a result of the use of the font software even if notified in advance of such possibility. In no event shall any liability of Upper Management exceed the purchase price of the License to the Font Software or replacement of the Font Software, either at Upper Management's sole discretion.

IO. EMBEDDING

Embedding of the Font Software on the web is expected and encouraged as part of this License. However, do not embed the font software in formats which can be easily stolen if possible. Do not embed the Font Software or any format from the Font in any application or usage outlined in the misuse category.

II. JURISDICTION

You agree that this Agreement between Upper Management and You was formed in the state of Texas, United States of America and any cause of action arising from it, arises in the State of Texas, United States and will be governed by and construed in accordance with the laws of the State of Texas and within the exclusive jurisdiction of the Texas courts.

Upper Management reserves the right to amend or modify this Agreement at any time and without prior notification. Any modifications will preserve the original permitted uses of this Agreement. Modifications may account for changes in technology that would otherwise impair or render obsolete provisions in this Agreement. Modifications shall not be applied retroactively and any original intended use cases will not be void as a result of any modifications. Upper Management will make such amended terms available at uppermanagement.co. If You do not agree to the modified terms, Your continued use of the Fonts could be in breach of the Agreement.

This Agreement embodies the entire understanding between Upper Management and You and supersedes all prior arrangements or understandings. If an applicable Court declares any part of it to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

I2. BREACHES OF LICENSE

Should the Licensee violate any provision of this agreement it is considered Null and Void and the Licensee agrees to contact Upper Management within five (5) business days to report said violation of this Agreement. Upon termination of this agreement all copies, both installed and archival, must be uninstalled and destroyed until such a time as a new Agreement is reached between the Licensee and Upper Management. All breaches of contract and their damages are solely up to the discretion of Upper Management and its legal representatives. Please contact Upper Management for any questions about breaching this contract.

I4. WARRANTY

Upper Management Co. warrants that the Font Software will continue to work for one (1) calendar year from purchase. Due to the nature of technology and constant new use cases, we do not guarantee the Font Software will work on every platform.

I5. REFUNDS

If an incorrect license is purchased, please contact Upper Management within sixty (60) days of the original purchase to inquire about purchasing the correct License type.

Full refunds are only given when the Font Software is proven defective and if Upper Management cannot repair the files in a minimum period of trouble-shooting and consultation of fifteen (15) working days from the time that the User alerts Upper Management to the issue.

I6. PROOF OF LICENSE

Upper Management, affiliates, or any of its successors reserve the right to request a copy of this License at any time. Retaining copies of this License is imperative to verify that the original Licensee is still in possession of the License and no breach of agreement has occurred. This License is automatically created in the original email of the purchase receipt.
